Matter: Notice of Data Security Incident

Dear Attorney General:

We represent Emmer Bros., LLC ("Emmer"), which is located in Norfolk, Nebraska. Our representation of Emmer relates to a data security incident described in more detail below. Emmer takes the security and privacy of the information in its control seriously, and has taken steps to prevent a similar incident from occurring in the future.

This letter will serve to inform you of the nature of the security incident, the number of Iowa residents being notified, what information has been compromised, and the steps that Emmer has taken to restore the integrity of the system. We have also enclosed a sample of the notification made to the potentially impacted individuals, which includes an offer of free credit monitoring.

### **Nature of the Security Incident**

On August 4, 2022, Emmer detected suspicious activity within its network environment. Upon discovery, Emmer immediately engaged a law firm specializing in cybersecurity and data privacy to investigate further. Additionally, Emmer engaged third-party forensic specialists to assist Emmer in its analysis of any unauthorized activity. The investigation concluded on May 18, 2023. While the potentially impacted information varies by individual, the investigation concluded that certain personal information – including names and addresses, and in some instances date of birth, social security number, driver's license/state identification card number, financial account number, and payment card information – were accessed by an unknown party that is not authorized to handle or view such information.

At this time, Emmer does not have any evidence to indicate that any personal information has been or will be misused as a result of this incident.

## **Number of Iowa Residents Affected**

A total of 971 residents of Iowa have been identified as potentially affected by this security incident. Notification letters to these individuals were mailed on May 30, 2023, by first class mail. A sample copy of the notification letter is attached.

#### **Steps Taken**

Upon detecting this incident, Emmer moved quickly to initiate a response, which included conducting an investigation with the assistance of IT specialists and confirming the security of the network environment. Emmer also reviewed and altered policies, procedures, and network security software relating to the security of systems and servers, as well as how Emmer stores and manages data.

Emmer offered free credit monitoring and identity theft protection services to all potentially affected individuals.

We recently discovered that a data security incident may have resulted in the possible unintentional exposure of your personal information. This letter contains additional information about the incident, our response to this incident, and steps you can take to protect yourself. Please be assured that the Emmer Bros., LLC ("Emmer") takes the protection and proper use of your personal information very seriously, and we sincerely apologize for any inconvenience this may cause.

#### What Happened:

On August 4, 2022, Emmer detected suspicious activity within its network environment. Upon discovery, Emmer immediately engaged a law firm specializing in cybersecurity and data privacy to investigate further. Additionally, Emmer engaged third-party forensic specialists to assist Emmer in its analysis of any unauthorized activity. The investigation concluded on May 18, 2023. While the potentially impacted information varies by individual, the investigation concluded that certain personal information – including names and addresses, and in some instances date of birth, social security number, driver's license/state identification card number, financial account number, and payment card information – were accessed by an unknown party that is not authorized to handle or view such information.

At this time, Emmer does not have any evidence to indicate that any of your personal information has been or will be misused as a result of this incident. Emmer is notifying you of this incident out of an abundance of caution.

#### What We Are Doing:

We take the protection and proper use of personal information very seriously. As part of our ongoing commitment to information privacy and the security of information, we are notifying you of this incident. Although we are not aware of any misuse of your information as a result of this incident, we are offering you complimentary credit monitoring and identity theft protection through IDX A ZeroFox Company, the data breach and recovery services expert.

IDX's services include: <<12/24>> months of credit and CyberScan monitoring, fully managed identify theft recovery services, and a \$1,000,000 Identity Theft Insurance policy. With this protection, IDX will help you resolve issues in the unlikely event that your identity is compromised.

IDX is available Monday through Friday from 6 a.m. to 6 p.m. Pacific Time, excluding holidays. Please note the deadline to enroll is August 30, 2023.

#### What You Can Do:

Further, as a best practice, we encourage you to remain vigilant against incidents of identity theft and fraud, to review your financial account statements, and to monitor your credit reports for suspicious activity. This letter also includes additional information and resources to assist you in protecting your personal information, should you feel it appropriate to do so.

#### **Additional Information**

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. To order your free credit report, please visit <a href="www.annualcreditreport.com">www.annualcreditreport.com</a>, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at <a href="https://www.consumer.ftc.gov/articles/0155-free-credit-reports">https://www.consumer.ftc.gov/articles/0155-free-credit-reports</a>) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281.

Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:

**Fraud Alerts:** You can place fraud alerts with the three credit bureaus by phone and online with:

- Equifax (https://assets.equifax.com/assets/personal/Fraud Alert Request Form.pdf);
- TransUnion (https://www.transunion.com/fraud-alerts); or
- Experian (https://www.experian.com/fraud/center.html).

A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. As of September 21, 2018, initial fraud alerts last for one year. Victims of identity theft can also get an extended fraud alert for seven years. The phone numbers for all three credit bureaus are at the bottom of this page.

Monitoring: You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

**File Police Report:** You have the right to file or obtain a police report if you experience identity fraud. Please note that in order to file a crime report or incident report with law enforcement for identity theft, you will likely need to provide proof that you have been a victim. A police report is often required to dispute fraudulent items. You can generally report suspected incidents of identity theft to local law enforcement or to the Attorney General.

FTC and Attorneys General: You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General.

You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
