The website provider for the Iowa Law Enforcement Academy experienced a breach on June 5, 2020. The ILEA website does not maintain any financial information, and no financial information was accessed. Roster information may have been accessed and may include the following:

- First and last name
- Employing Agency
- Driver's License number or Social Security Number
- Rank or position

The Iowa Law Enforcement Academy conducted a review and it was determined approximately 11,000 names and roster information may have been accessed.

The Iowa Law Enforcement Academy with the assistance of the Office of the Chief Information Officer notified effected parties by available email addresses. A letter was attached to each email encouraging each party to closely monitor all personal information and credit reporting through the following: Equifax www.equifax.com/person 1 (888) 548-7878; Experian www.experian.com 1 (888) 397-3742 or Transunion www.transunion.com 1 (800) 916-8800 and to report any suspected incidents of identity theft to local law enforcement or the Attorney General's Office.
