Re: Notice of Data Event

Dear Sir or Madam:

We represent Numrich Gun Parts Corporation (“Numrich”) located at 226 Williams Lane, Kingston, New York 12401, and write to notify your office of an event that may affect the security of certain personal information relating to approximately six hundred nine (609) Iowa residents. This notice may be supplemented if any significant new facts are learned subsequent to its submission. By providing this notice, Numrich does not waive any rights or defenses regarding the applicability of Iowa law, the applicability of the Iowa data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about March 28, 2022, Numrich became aware of suspicious activity occurring within its e-commerce website, www.gunpartscorp.com. Numrich immediately launched an investigation, with the assistance of third-party computer forensic specialists, to determine the nature and scope of the event. The investigation determined that an unknown actor gained access to certain customer payment information entered into the website between January 23, 2022, and April 5, 2022. Numrich’s remediation efforts removed the unknown actor’s access on that date. Once the investigation was complete, Numrich undertook a thorough review of its records to determine which customers made purchases during that time. This review recently completed.

The information that could have been subject to unauthorized access was name, address, and payment card information, including card number, security code, and expiration date.

Notice to Iowa Residents

On June 6, 2022, Numrich began providing written notice of this event to affected individuals, including approximately six hundred nine (609) Iowa residents. Written notice is being provided in substantially the same form as the letter attached hereto as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon learning of this event, Numrich promptly took steps to confirm the security of its website and investigate the activity. Numrich worked quickly to secure its website and implement additional network and endpoint monitoring to reduce the risk of recurrence. Numrich also engaged with federal law enforcement. Numrich further established a dedicated assistance telephone line to address and questions or concerns from notified individuals.

Additionally, Numrich is providing potentially impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected events of identity theft or fraud to their credit card company and/or bank. Numrich is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for events of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state attorney general, and law enforcement to report attempted or actual identity theft and fraud.

Numrich Gun Parts Corporation (“Numrich”) is writing to inform you of an event that may impact the security of certain customer information. While we are unaware of any actual misuse of information related to this event, we are providing you with information about the event, our response, and steps you may take to protect against any misuse of your information, should you feel it appropriate to do so.

What Happened? On or about March 28, 2022, we became aware of suspicious activity occurring within our e-commerce website, www.gunpartscorp.com. We immediately launched an investigation to determine the nature and scope of the event. The investigation recently determined that an unknown individual gained access to certain customer payment information entered into the website between January 23, 2022, and April 5, 2022. Our prompt remediation efforts removed the actor’s access on that date. Once the investigation was complete, we undertook a thorough review of our records to determine which customers made purchases during that time.

What Information Was Involved? Our records indicate you made a purchase on our website during the above time period. Therefore, the following information related to you may have been impacted: name, address, and payment card information, including card number, security code, and expiration date.

What We Are Doing. We have strict security measures in place to protect information in our care. Upon learning of this event, we promptly took steps to confirm the security of our systems and investigate the activity. We worked quickly to secure our website and implement additional network and endpoint monitoring to reduce the risk of recurrence. We also engaged with federal law enforcement and notified appropriate governmental regulators.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud, to monitor your accounts for any unusual activity and to detect errors, and to report any instances of theft or fraud to law enforcement. Please review the enclosed *Steps You Can Take to Help Protect Personal Information*, which contains information on what you can do to better safeguard your information.

STEPS YOU CAN TAKE TO PROTECT PERSONAL INFORMATION

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

You may further educate yourself regarding identity theft, fraud alerts, credit freezes, and the steps you can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or your state attorney general. The Federal Trade Commission may be reached at: 600 Pennsylvania Avenue NW, Washington, DC 20580; www.identitytheft.gov; 1-877-ID-THEFT (1-877-438-4338); and TTY: 1-866-653-4261. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. You can obtain further information on how to file such a complaint by way of the contact information listed above. You have the right to file a police report if you ever experience identity theft or fraud. To file a report with law enforcement for identity theft, you will likely need to provide some proof that you have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and your state attorney general. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit “prescreened” offers of credit and insurance you get based on information in your credit report; and you may seek damages from violator. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
