I still used Shelter on my face for backup which my daughter took because she loved it. She used the UV 15 too and didn't burn. We got the nicest tan. I burn in 10 minutes normally, Irish white skin

In Vegas I got really dark fast. In Palm Springs the Manager of Sunstone used it and she didn't burn, she tanned. We took it at the same time and it was an hour before. It was a chlorinated pool from about 10:30 -1:30 so it. I was working by the way just stayed for the weekend because of the 405 shut down all weekend and I worked the dessert cities.
