

("Anthem") is supplementing the notice provided to your office on February 6, 2015 and July 7, 2015 regarding the widely-reported cyber attack perpetrated against the company with the attached and updated list of entities on whose behalf Anthem is providing notice pursuant to Iowa Code §715C et. seq. As you know, your state breach law requires notice to your office where 500 or more Iowa residents have "personal information," as defined by your state law, affected in a breach.

Anthem is submitting these materials as part of its data breach notification obligations under state breach law. Anthem included certain employers and/or plans in the list that may not be required to report given the scope of the breach out of an abundance of caution and in the interest of prompt notification to affected individuals.

The information provided in this report was collected as part of an ongoing investigation and is accurate to the best of our knowledge. Information in this report may change as the investigation continues.
