Re: Centene Settlement –Attorney Fee Payment

Dear Tina:

With the execution of the Office of the Attorney General of Iowa (OAG) Settlement Agreement with Centene Corp. (Centene) and the OAG's receipt of the first of two settlement payments, I write to request payment of the attorney contingent fee pursuant to the Counsel Retention Agreement (Agreement) executed on September 19, 2022, *see* enclosure.

Exhibit A of the Agreement sets forth the Iowa statutory contingent fee schedule that governs the calculation of the attorneys' aggregate compensation in this matter. The recovery from the Settlement Agreement is \$44,455,199, and it is to be paid in two equal payments—the first payment was made on January 27, 2023 and the second payment is to be made on or before January 27, 2024. Pursuant to the Iowa statutory contingent fee schedule, the contingency fee payment is in the amount of \$5,722,759.95.

Accordingly, the following payments are due via wire transfer to Cohen Milstein upon the OAG's receipt of settlement payments from Centene:

Attorney Fee Payment #2 \$2,861,379.97 Due by February 6, 2024
